This privacy statement applies when you visit one of our websites, place an order or enter into an agreement.

## Processing personal information

We carefully handle your data in accordance with the European GDPR guidelines as implemented by the Dutch 'Algemene verordening gegevensbescherming (AVG)'. The Dutch WKGZ and WGBO laws tells us to keep our records at least fifteen years after the last information recording or consultation before January 1<sup>st</sup> of 2020 and at least twenty years after the last information recording or consultation from January 1<sup>st</sup> of 2020.

Personal information is all information that directly or indirectly identifies you. We use that information for:

- Enabling us to do our therapist work
- Enabling you to pay for therapy or coaching
- To provide you with a bill for the Dutch Health insurance
- Send you a newsletter
- Contact you through phone, post or any digital way like e-mail
- Inform about changes in our services and products

We process the following personal information:

- first and last name, gender
- date of birth, place of birth
- address details,
- phone number(s), email addresses
- IBAN
- IP-address
- other personal information a client/customer provides. That is information necessary for treatment or coaching, in line with the Dutch WKGZ and WGBO legislation in mind.

We use electronic information from our websites and other digital business statements. Such as IP addresses and if necessary, references to pages like LinkedIn and Facebook that are offered by you.

Our websites automatically collect statistical information such as IP address, number and frequency of visits. The recorded information is anonymized. The information is used for evaluation and improvement of the website by a statistics package.

We use Functional cookies. These are necessary for the functioning of the website. After your visit these cookies are removed by your browser.

## **Providing of personal data to other parties**

Applications delivered by third parties are being used. Therefor the IP-address is needed for delivering the content to your browser. Examples of these applications are:

- Google Fonts for displaying text.
- Google Maps for displaying a map for our Practice locations.
- Google ReCaptcha for rejecting form spammers.

We do NOT provide information about you to other parties, unless necessary for filing illegal acts to legal authorities.

## **Your privacy rights**

You are entitled to inspect your personal data (Article 35 of the Dutch Wbp) and the right to request correction or deletion of your personal data (Article 36 of the Dutch Wbp). You can also object to the use of your data. After removal of data, the request for deletion is kept as a result of the WKGZ and WGBO laws.

In order to ensure that we send the personal details to the right person, we ask you to send a copy of your identity card. Make sure you black the following fields: the strip containing numbers at the bottom of the passport, passport number, citizen service number, photo.
